Medical Assistance Program Fair Hearing Relocation Update

This Alert is to advise Medicaid Providers, Hospitals, Client Representatives, Community Based Organizations, Advocates, Agencies and Entities assisting Medicaid consumers that, the Human Resources Administration (HRA) Medicaid Fair Hearing Division has relocated several of their units. These Fair Hearing units are now co-located in Brooklyn at buildings where HRA programs are located. They are no longer co-located with the State's Office of Temporary and Disability Assistance (OTDA) Fair Hearing division.

This update is to add additional FH units that have relocated to 495 Clermont Avenue. The entrance to the program is located at 495 Clermont Ave, Brooklyn, NY 11238. Individuals or representatives visiting the office regarding a Fair Hearing matter, should obtain a ticket at the kiosk to the 4th floor at window 7. Please bring identification when visiting the program.

The following are the fair hearing units and their new locations:

Conference: MAP Fair Hearing Division - the Fair Hearing Conference unit assists individuals and/or entities that request a hearing by reviewing the issue prior to the Fair Hearing and helping to achieve a resolution.

Compliance and Aid to Continue unit - this unit manages the compliance with fair hearing decisions issued by OTDA's Administrative Law judges. The unit also acts on any aid to continue directives ordered by OTDA. **This unit is now located at 495 Clermont Avenue.**
