¹ **2024 Benchmark Premium** = \$48.72 - Benchmark plans are BASIC plans with premiums below the "benchmark" – and are free for people with Full Extra Help. Extra Help subsidizes the BASIC plan premium up to the benchmark. For "Enhanced plans," the Extra Help subsidy is more complicated – the premium for Extra Help members may not be \$0 even if the premium is below the benchmark. See complete PDP plan list. Anyone with Extra Help is randomly assigned to benchmark plans if they don't select any plan. It is ALWAYS better to CHOOSE the best plan based on your drugs than to be randomly assigned.

³ Members of closing plans who do NOT have Extra Help also receive notice from the plan in Oct. and CMS in November (Notice #11438) stating that plan is closing and that they need to pick a different plan for 2024, but they are **not reassigned to a plan** if they do not pick one. If they do not choose a new plan to start Jan. 1, 2024, they receive a CMS Non-Renewal Action Notice No. 11452 in January reminding them that they have a Special Enrollment Period ending February 28, 2024 to join a plan.
