



## **Temporary Protected Status (TPS) and Public Health Insurance**

Haitian individuals who have applied for Temporary Protected Status (TPS) may be eligible for public health insurance in New York State.

### **Pwoteksiyon Tempore Et Asirans Medikal publik**

#### **What is Temporary Protected Status?**

TPS is a temporary immigration status granted to eligible individuals of a certain country designated by the Department of Homeland Security because serious temporary conditions in that country, such as armed conflict or environmental disaster, prevents people from that country to return safely. On January 21, 2010 the United States determined that individuals from Haiti warranted TPS because of the devastating earthquake that occurred there on January 12. TPS gives undocumented Haitian residents, who were living in the U.S. on January 12, 2010, protection from forcible deportation and allows them to work legally. It is important to note that the U.S. grants TPS to individuals from other countries, as well, including individuals from El Salvador, Honduras, Nicaragua, Somalia and Sudan.

#### **Ki sa ki pwoteksyon tempore**

En Janvié 21, 2010 les Etazinis détermine ke moun ki sot Ayiti mérité pwoteksiyon tempore kontre loua immigrasyon. Proteksyon sa bay Ayisian ki isi na Etazins ki ap viv isi san dokuman et ki tap viv dans Etazini depuis Janvié 12, 2010 pwoteksiyon kontre depotasyon et pwoteksiyon sa bay Aysian sa yo pemisiyon pou yo kap travay na peyi isi légalement. Li important pou noté ke les Etazuni bay pwoteksiyon a lot peyi kom El Salvador, Honduras, Nikaragua, Somalia et la Soudain.

#### **TPS and Public Health Insurance**

TPS applicants residing in New York are eligible for Medicaid and Family Health Plus as long as they also meet the income requirements for these programs. In New York, applicants for TPS are considered PRUCOL immigrants (Permanently Residing Under Color of Law) for purposes of medical assistance eligibility and thus meet the immigration status requirements for Medicaid, Family Health Plus, and the Family Planning Benefit Program. Nearly all children in New York remain eligible for Child Health Plus including TPS applicants and children who lack immigration status.

#### **TPS é Asirans Medikal Public**

Nan Nouyok, yo considéré moun ki apliké pou TPS kòm sa yo réle PRUCO immigrant (Resident Permanan daprés la loi) min simpléman pou yo kapab kalifye pou asirans medikal. En éfèt li vin fè moun sa yo kalifye pou

Médikéd, Family Health Plus et asirans yo rélé Family Planning Bénéfit Program dapre la loua imigrasyon. Prèské tout ti moun ki ap viv nan Nouyòk la kalifyé pou asirans yo rele Child Health Plus é mim pou ti moun ki apliké pou TPS et mim pou ti moun ki pa ki ginyin résidans yo.

### **Where to Apply**

Individuals may apply for public health insurance with facilitated enrollers at community-based organizations or health plans, at HRA Medicaid offices in New York City, Social Services offices outside of New York City, public hospitals, and Department of Health Clinics. ### **What to Bring**

Individuals who have applied for TPS will need to bring several documents to prove their eligibility for public health insurance. Individuals will need to bring:

- 1) Proof of identity;
- 2) Proof of residence in New York;
- 3) Proof of income;
- 4) Proof of application for TPS;
- 5) Proof that U.S. Citizenship and Immigration Services (USCIS) has received the application for TPS.

### **Kisa Pou ou Poté**

1. Dokimantasyon pou prouvé identifikasyon yo
2. Dokimantasyon pou prouvé ké yo sé résidans de Nouyòk (Prèv ké ou abité nan Nouyork la)
3. Dokimantasyon pou prouvé salè ou kombyen largent ou fè
4. Dokimantasyon pou prouvé ké ou té apliké pou TPS
5. Dokimantasyon ki prouvé ké imigrasyon té résévoua aplikasyon-ou pou TPS

### **Free Communication Assistance**

All applicants for public health insurance, including Haitian Creole speakers, have a right to get help in a language they can understand. All Medicaid offices and enrollers are required to offer free communication assistance. Oral interpretation services should be provided and important documents, such as Medicaid applications, should be translated either orally or in writing. If a Medicaid office or enrollment site cannot provide a bilingual enroller or in-person interpreter, an interpreter over the telephone may be used instead. Medicaid offices and enrollers must not charge a fee for communication assistance or require that applicants bring their own interpreter.

Si yon ofis Médikéd ou yon ofis ki ap aksépté aplikasyon pou médikal pa kabab bay yon interprèt soua yon interprèt en person yo supozé bay yon interprèt sou tèlèfòn. Ofis Médikéd yo pa supozé chargé okun largen pou yo bay ède pour komunikasyon é yo pa supozé ni yo pa kab égzigé moun kap apliké yo pou yo vini avèk pròpe interprète pa yo.
